

**THE GROWING TREE CHILD CARE CENTER TUITION RATES**

**\*Annual tuition increase will occur each September. Please understand that these increases assist in the rising cost of health insurance, goods and services for your children, and our annual salary increases\***

- A \$50 NON-REFUNDABLE, initial registration fee is due at registration and a \$30 NON-REFUNDABLE registration fee is required for every child after.
- Tuition payment can be made in the form of cash or check only.
- Tuition is to be paid prior to the service being rendered. Your tuition is due every Monday. If a holiday falls on a Monday, tuition will be due the prior Friday. Your tuition represents your child's placement in our early childhood education programming. There is no credit provided in the event the center has an emergency closure or holidays that fall during the week. A late tuition fee of \$25.00 will be assessed to your account if your payment is not received on or before the tuition date. Failure to make payment will result in suspended child-care services until the tuition and any assessed fees are paid in full. A service charge of \$35 will be charged for each check returned for your insufficient funds. If two checks return insufficient funds, all subsequent payments must be made in cash, money order, or certified bank check only.
- Change of days attending can be made with the Directors only as far in advance as possible with the understanding that these days will be based on our availability only. You may hold a full-time spot over the summer months but attend part-time. 1. Your tuition rate will be 50% of the full-time rate and permit your child 2 days of attendance based on our availability only. 2. Your tuition rate will be the 3-day rate and permit your child 3 days of attendance based on availability only. These are the only 2 options we provide!
- Withdrawal requires a minimum of 2 weeks' notice and if you choose not to bring your child once the notice is provided to the Directors, PAYMENT IS STILL DUE FOR THESE 2 WEEKS!
- A multi-child discount applies when your children attend **full-time only**. There is a 10% discounted rate off the oldest child's tuition rate.
- DISCOUNTS ONLY APPLY TO FULL-TIME CHILD-CARE. DISCOUNTS DO NOT APPLY TO FAMILIES THAT ONLY ENROLL FOR SUMMER!

**School Age Rates: Kindergarten through 6<sup>th</sup> Grade (during school year)**

**Before and After Care**

4 or 5 days per week (FT)	\$115	FT Rates ONLY include all snow days, and early dismissals. NO EXTRA CHARGE APPLIES!
3 or less days per week (PT)	\$95	

**Before Care Only**

4 or 5 days per week (FT)	\$75	PT Rates will incur an additional fee of \$60 per holiday, snow day, and early dismissal. FT is guaranteed these days automatically. PT must be requested on these days and authorized.
3 or less days per week (PT)	\$55	

**After Care Only**

4 or 5 days per week (FT)	\$95
3 or less days per week (PT)	\$75

**School Age Rates: Kindergarten through 6<sup>th</sup> Grade (Summer Camp Programming)**

4 or 5 days per week (FT)	\$185	School Age Summer Camp Programming FT or PT incurs an automatic \$175 field trip/activity Fee.
3 or less days per week (PT)	\$165	

**\*\*\*PLEASE NOTE THAT SCHOOL AGE SUMMER CAMP PROGRAMMING PT STATUS IS 3 DAYS OR LESS. THIS INCURS A MAXIMUM OF 24 HOURS PER WEEK THAT YOUR CHILD/REN MAY ATTEND. IF YOU EXCEED THE 24-HOUR PER WEEK MAXIMUM, THE \$60 PER DAY CHARGE WILL APPLY TO YOUR TUITION RATE AUTOMATICALLY. THANK YOU\*\*\***
